It provides postemergence control of annual, biennial and perennial broadleaf weeds in established turfgrass, including residential lawns, golf courses, parks, sports fields, sod farms and around commercial buildings and other recreational and commercial turfgrass areas

- Do not apply TCS Growstar LockUp with 2,4-D and Dicamba on Fertilizer, carpetgrass, dichondra, St. Augustinegrass, bahiagrass, or to golf course putting greens or tees, or turfgrass containing desirable clovers.

Penoxsulam 3 FERT, which contains the active ingredient penoxsulam is a Group 2 herbicide based on the mode of action classification system of the Weed Science Society of America.

Apply TCS Growstar LockUp with 2.4-D and Disamba on Fertilizer using a rotary-type spreader designed to apply granules. Calibrate application equipment prior to use according to the manufacturer's directions. Check frequently to be sure equipment is working properly and distincting granules uniformly. Do not use spreaders that apply malerial in narrow concentrated bands. Avoid skips or overlaps as poor weed control or turfgrass injury may occur. More uniform application may be achieved by spreading half of the required amount of product over the area and then applying the remaining half in swaths at right angles to the first.

Application Techniques for Applying TCS Growstar LockUp with 2,4-D and Dicamba on Fertilizer

When using a drop-type spreader, a splashboard mounted under the hopper will provide more even granule distribution

A chain fastened to the side of the spreader and allowed to drag on the soil surface can be used to mark the edge of the treated swath and help prevent skips or overlaps

For treating smaller areas, use a hand held or push-type rotary applicator such as a whirlybird or cyclone unit. For hand held units, walk and turn the crank at a constant rate of speed.

For small, difficult to treat areas use a shaker-type applicator made from a small container with holes punched in the bottom. Carefully measure the amount of product needed to avoid over application

Rates and Timing of Application

Apply 150 to 175 lb of TCS Growstar LockUp with 2,4-D and Dicamba on Fertilizer per acre (3.4 to 4 lb per 1000 sq ft) per application to established turfgrass. Possible re-treatment in approximately 30 days may be necessary if turfgrass is heavily infested with weeds or if adverse low moisture conditions prevail and weeds are in a state of poor growth. Do not exceed 350 lb of TCS Growstar LockUp with 2.4-D and Dicamba on Fertilizer per acre (8 lb per 1000 sq ft) per year because damage to turfgrass may occur. Do not make more than two applications per season.

Precaution: When applying to warm season turfgrass under conditions of inadequate moisture, high temperature and high humidity, over-application may cause minor transitory discoloration. Redu application rates by 50% during hot, dry conditions to avoid possible dehydration or browning of turfgrass.
